Distinguished delegates,  
Ladies and gentlemen,

Let me, once again, thank the Government of Belize and its people for the warm hospitality extended to us during our stay. I also wish to commend Belize for your leadership as Chair of this Caribbean Regional Preparatory Meeting which, concludes the three regional preparatory meetings for the Mid-term review of the SAMOA Pathway.

I would like to acknowledge with much appreciation H.E. Ms. Lois Young and Ambassador Felson, for the close cooperation with OHRLLS and UNDESA in the organisation of this important meeting.

And I thank all participants, panelists and moderators for your valuable and substantive contributions to the thematic sessions and for articulating the thematic priorities of the Caribbean SIDS which needs to be brought to the forefront of the discussions on the Mid-term review of the SAMOA Pathway. We can all be proud of the outcome document of the meeting following the deliberations over the last four days.

This Regional preparatory meeting has touched upon the important findings of the JIU Review on the UN system including the Secretariat & Funds and Programmes support to SIDS. As you are well aware, this review was conducted after the SIDS Conference in Samoa in 2014, as requested by the Member States and the three reports issued by the JIU put forward important recommendations on how to bridge the existing gap, and enhance the coordination of support provided to SIDS in meeting their aspirations for sustainable development.

In line with these recommendations, the Secretariat has accepted these recommendations and have commenced its implementation. Specifically in regard to the recommendations relating to the need to strengthen coordination of activities between the two SIDS units of DESA and OHRLLS, I would like to stress that the Secretariat, for its part have taken concrete steps to institutionalise their collaboration. These include regular lines of communication at the director's level have been established to ensure better coordination and planning of work in support of small island developing States. An "alternate chairing" arrangement of the meetings of the Inter-Agency Consultative Group or the IACG on Small Island Developing States, composed of members from United Nations agencies, regional commissions and entities, and non-governmental organizations.

In this regard, I also note the adoption of the Terms of Reference of the IACG to enhance coherence and effective coordination between United Nations agencies and relevant stakeholders and improve communication and consultation with Member States which was taken note of by the General Assembly in its resolution 72/217 last year.

Clearly, more needs to be done. Here, I urge you to take opportunity of the processes with the potential to enhance UN system's support to SIDS including the MTR itself, the reposting of the UN development system and the Needs Assessment Report which will be submitted to the General Assembly in September this year.

Ladies and gentlemen,

I would like to reiterate that the outcomes from the meeting, will provide a comprehensive summary of the discussions. As with the Regional Preparatory meetings of the AIMS and the Pacific, this includes three documents — firstly the Caribbean regional report, to be finalized, following inputs from Member States by the 24<sup>th</sup> August 2018. Second, is a Report of the Meeting summarising the sessions which will be issued by the Secretariat and the Outcome document which has just been adopted. All these documents will be made available to Member States in time for the inter-regional meeting in Samoa in late October.

The meeting has provided clear directions on the way forward. The meeting has been clear on action to accelerate the further implementation of the SAMOA Pathway over the next five years. I wish to commend you on the very substantive nature of your outcome, and in particular, the priorities identified toward a programme of implementation for the region.

The United Nations system is your system and is committed to support you.

We look forward to continuing this journey with you as you carry on the process of accelerating progress toward making sustainable development of SIDS a reality for your people.
